### ALTERNATIVE 1 - NORTHBOUND OLD TOWNE



### FEAUTURES OF ALTERNATIVE 1

- Alternate merge and traffic signal on Sam Rittenberg Boulevard near the merge are eliminated
- Traffic signal added at Old Towne Road & Sumar Street
- Traffic signal added at Sam Rittenberg Boulevard & Sumar Street

- New traffic pattern provides drivers on Old Towne Road dedicated lanes north onto Sam Rittenberg Boulevard
- Drivers commuting from the Cosgrove Bridge to Old Towne Road will stay on Sam Rittenberg Boulevard and make a left onto Sumar in order to access Old Towne Road

### ALTERNATIVE 2 - NORTHBOUND OLD TOWNE "T"



### FEAUTURES OF ALTERNATIVE 2

- Alternate merge and traffic signal on Sam Rittenberg Boulevard near the merge are eliminated
- Traffic signal added at Old Towne Road & Sumar Street
- Traffic signal added at Sam Rittenberg Boulevard & Sumar Street
- Drivers on Old Towne Road will veer slightly left before making a right turn onto Sam Rittenberg Boulevard using either a free-flowing dedicated turn lane or a yeild sign before accessing the middle lane
- Drivers commuting from the Cosgrove Bridge to Old Towne Road will stay on Sam Rittenberg Boulevard and make a left onto Sumar Street in order to access Old Towne Road



Based on feedback from over 400 citizen comments during the first public comment period, as well as additional traffic study information, the Sumar Street Extension and Orange Grove Road Roundabout have been eliminated from further study.

In keeping with the goals of the project: to improve safety and traffic flow and provide bike and pedestrian connectivity throughout the study area, the two alternatives presented tonight share the following features.

### SHARED FEATURES IN ALTERNATIVE 1 & ALTERNATIVE 2



Based on historical collision data, access points for the Northbridge Shopping Center have been changed for safety purposes.



Traffic flow will improve at Orange Grove and Sam Rittenberg due to an additional left turn lane.



Both alternatives include the addition of new sidewalks, street crossings and multi-use paths within the project limits.
